

## ΒΙΟΓΡΑΦΙΚΟ ΣΗΜΕΙΩΜΑ

'Ο *Ludwig Wittgenstein* γεν. τδ 1889 στή Βιέννη. Σπούδασε μηχανική, μαθηματικά, φιλοσοφία και λογική στήν 'Αγγλία κοντά στόν Russell και στήν Jena με τόν Frege. Μετά τήν αιχμαλωσία του ἀπό τούς 'Ιταλούς στόν 1ο παγκόσμιο πόλεμο, δίδαξε σὲ δρει ὑ δημοτικά σχολειά τῆς Λύστρας. Τδ 1929 έγινε Fellow τοῦ Trinity College και τδ 1939 διαδέχτηκε τόν G.E. Moore στήν έδρα τῆς φιλοσοφίας στό Πανεπιστήμιο τοῦ Cambridge. Πέθανε στό Cambridge στίς 29.4.1951.
