Προτιμήσαμε νὰ καταχωρήσουμε βιβλία ἢ συλλογὲς ἄρθρων ἀντὶ χωριστὰ ἄρθρα ποὺ εἶναι, γενικά, πιὸ δυσεύρετα. Γιὰ λόγους οἰκονομίας ἀκολουθήσαμε τὴν ἀρχὴ νὰ μὴν ἀναφέρουμε ἓνα ἄρθρο ὅταν περιλαμβάνεται σὲ μιὰ ἀπὸ τὶς ἀνθολογίες ἢ συλλογές. Ἡ κατάταξή μας δὲν μπορεῖ νὰ εἶναι σὲ «στεγανές» κατηγορίες· τὴν υἱοθετήσαμε γιὰ νὰ ἀναφέρουμε χωριστὰ ἐργασίες στὴν περιοχὴ τῆς πρακτικῆς φιλοσοφίας, τῆς ἱστοριογραφίας καὶ τῆς αἰσθητικῆς ποὺ δὲν ἀντιπροσωπεύονται καθόλου στὸ τεῦχος τοῦτο τοῦ Δευκαλίωνα.
