

Βιβλιογραφία

Ἡ βιβλιογραφία ποὺ δίνουμε ἐδῶ εἶναι κατ' ἀνάγκη περιορισμένη. Περιοριστήκαμε σὲ εἰσαγωγικά, γενικά βιβλία, μονογραφίες καὶ ἄρθρα σχετικά μὲ τὰ θέματα τῶν ἐννοιῶν, τῆς ἐμπειρίας, τῆς ἐξήγησης, τῶν νόμων καὶ τῶν θεωριῶν καὶ σὲ ἱστορικῆς σημασίας ἔργα ἢ σχετικά μὲ τὴν ἱστορία τῆς ἐπιστήμης. Παραλείψαμε τὰ σχετικά μὲ τὰ μαθηματικά, τὴν πιθανότητα καὶ τὶς ἐπιμέρους ἐπιστήμες: φυσικὴ, βιολογία, ψυχολογία, ἱστορία, κτλ. — μολονότι ὁ ἀναγνώστης ποὺ θέλει νὰ ἔχει μιὰν εἰκόνα τοῦ χώρου τούτου πρέπει βέβαια νὰ ἐξοικειωθεῖ τουλάχιστο μὲ τὴ θεωρία τῆς σχετικότητας. Ἀκολουθήσαμε τὴν *Selective Bibliography of the Philosophy of Science* τῶν R. Harré καὶ John Hawthorn (Oxford, 1974). Οἱ ἑλληνικοὶ τίτλοι στὸ τέλος τῆς βιβλιογραφίας εἶναι μόνο ἐνδεικτικοί· ἀσφαλῶς θὰ ἔχουμε παραλείψει τοὺς σημαντικότερους. Εὐχόμαστε νὰ γίνῃ μιὰ προσπάθεια διεξοδικῆς ταξινόμησης τῆς ἑλληνικῆς βιβλιογραφίας.
